Pursuant to A.R.S. 38.431.02, notice is hereby given to the members of the Apache Elementary School District #42 community that the Apache School District Board of Education will hold a meeting open to the public on the second Tuesday of each month beginning at 5:30 pm at the Apache Elementary School.
